- 4. We may use group or class photographs or footage with very general labels, e.g. 'science lesson'.
- 5. We will only use images of pupils who are suitable dressed.
- 6. We will make every effort to ensure that we do not allow images to be taken of any children for whom we do not have permission or who are 'at risk' or disallowed from having their photographs taken for legal or social reasons.
- 7. We will take all reasonable measures to ensure the images are used solely for the purposes for which they are intended. However, we cannot guarantee this and take no responsibility for the way images are used by other websites or publishes or for any consequences arising from publication.
